If any one or more of the provisions contained in this agreement is, for any reason, held to be invalid, illegal, or unenforceable in any respect, that invalidity, illegality, or unenforceability will not affect any other provisions of this agreement, but this agreement will be construed as if those invalid, illegal, or unenforceable provisions had never been contained in it, unless the How To Draft An Independent Contractor Agreement of those provisions would result in such a material change so as to cause completion of the transactions contemplated by this agreement to be unreasonable. Contractor agrees that any breach of the Confidentiality obligations will cause immediate irreparable harm to Company and Contractor agrees that Company may obtain immediate injunctive relief to restrain Contractor from any breach or threatened breach of the provisions without the requirements of posting bond or proving the inadequacy of monetary damages. For instance, weekly one-on-one meetings with a supervisor or weekly status reports—which are the norm in employment relationships—should be avoided with contractors.
